As you will no doubt know, this sorming at an reximately 9.00cm a former member of our fils unit, Avraham Yisraeli, forced his way into my car at the dison han and during the course of the journey up to the Hotel Mefat, he threatened with physical violence both syself and my driver, Yacov Farjon.

We stopped by a police car and told the officers that was taking place and we all then proceeded to your police station where this said man, in the resence of your officers, continued to threaten se and the film that we are producing here.

As you may know, this man has recently been involved in an accident and he has a most excitable and possibly dangerous character and I consider his threats to me, my personnel and my film to be very serious indeed, and I would be obliged if you would take whatever steps necessary and within your power to see to it that this man is forced to restrain himself. As he has threatened to disrupt our work we must request that a police officer be placed on duty with the unit for the rest of our filming here, which will finish this coming weekend, so that, should this man appear he can be removed.
